Until **February 23, 2024**, the Group requesting the housing block may release up to 10% of the Total Room Nights booked without penalty. Should the actual rooms utilized (i.e., Total Room Nights booked less no shows and cancellations) be less than 90% of the Total Room Nights booked, the Group agrees to pay Connections Housing for the number of Sleeping Rooms not utilized up to 90% of the Total Room Nights booked.

The deadline for cancellations up to 10% (as specified above) is **February 23, 2024**. After this date, you will be held responsible for 100% of the total room nights booked, due and payable to Connections Housing within thirty (30) days of the conclusion of the conference.
